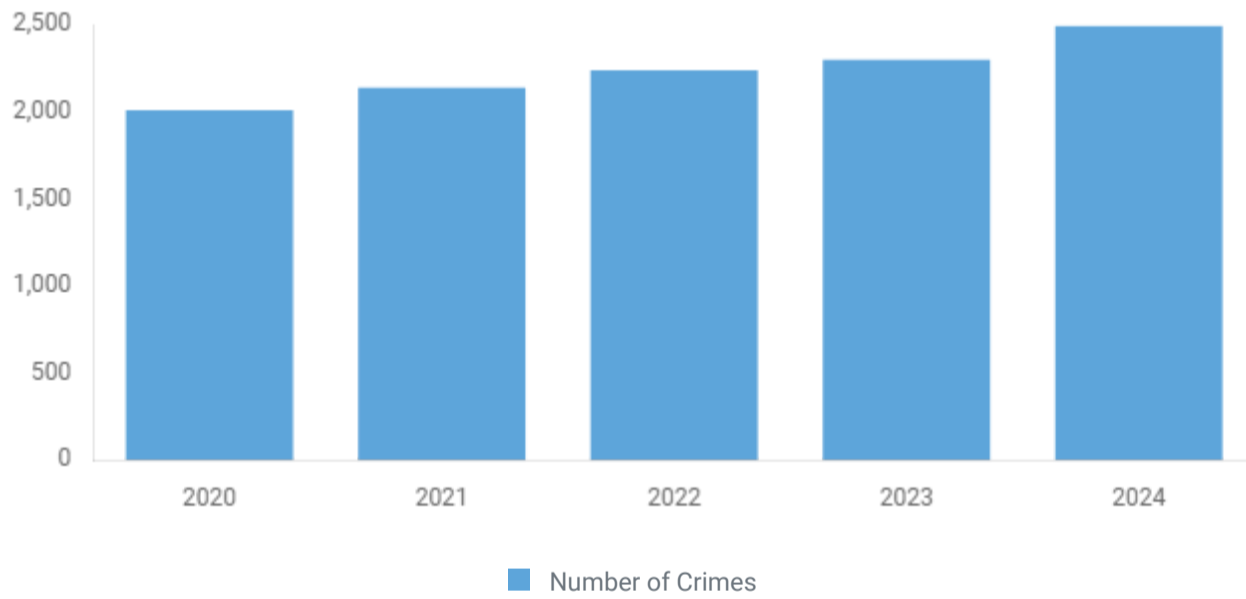

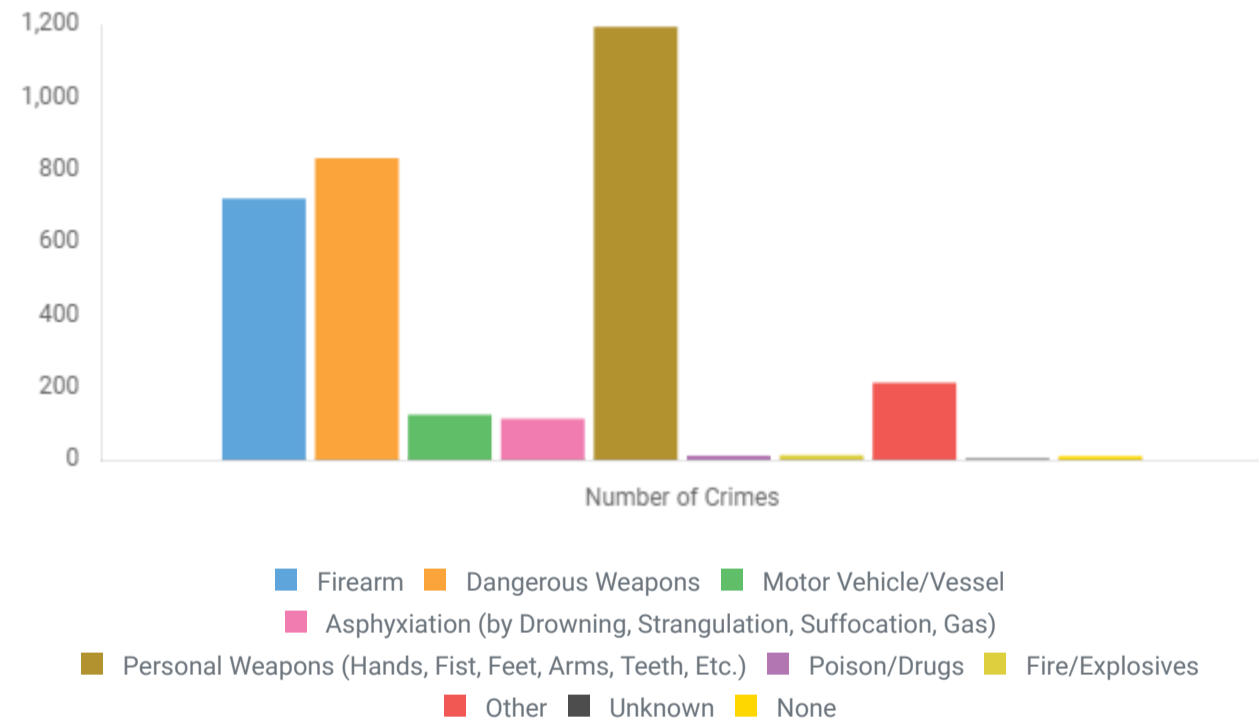

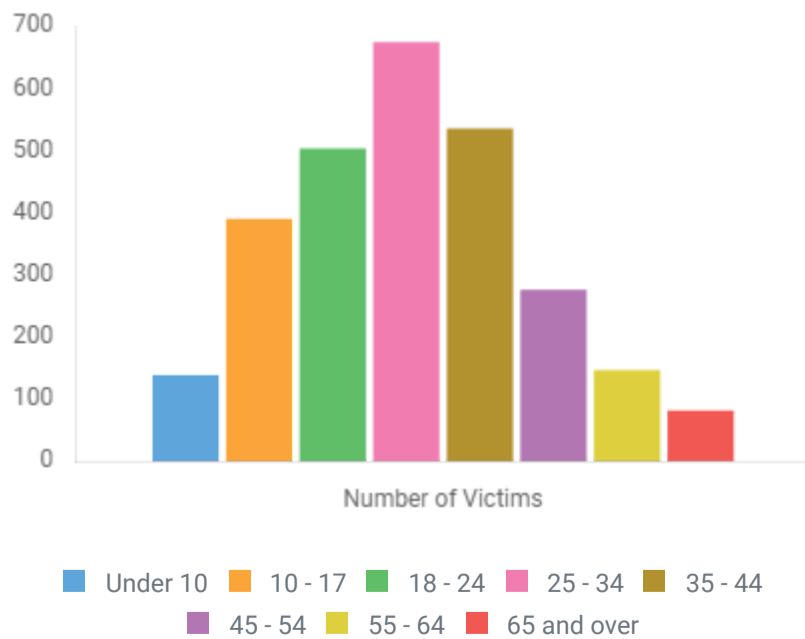
VIOLENT CRIME BY WEAPON TYPE

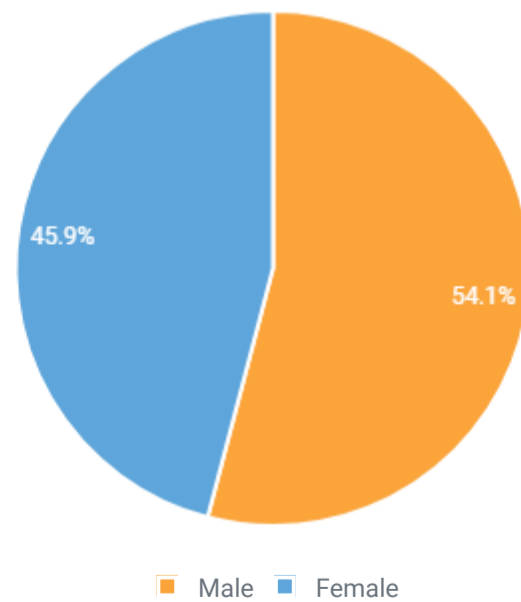
VICTIMS OF VIOLENT CRIME - AGE

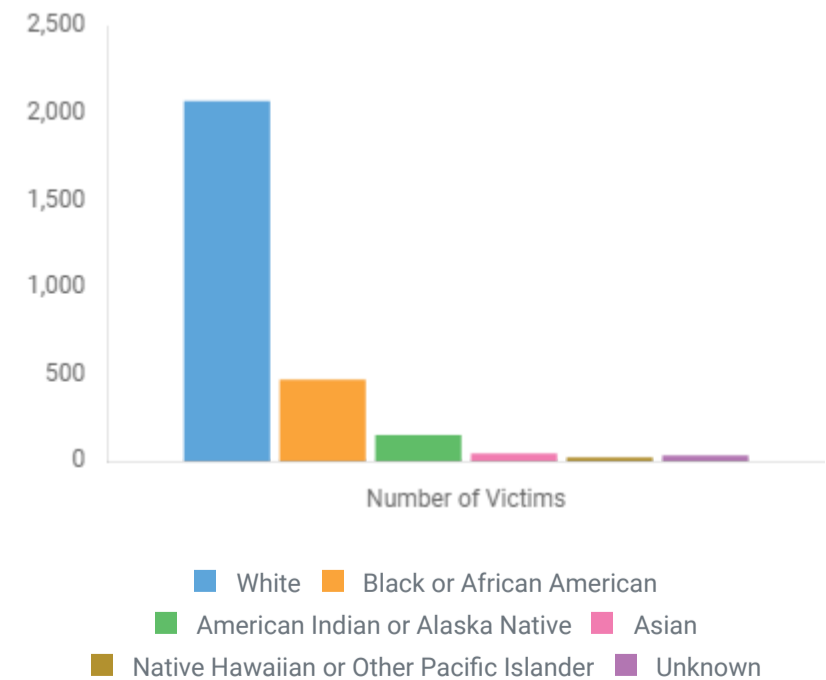
VICTIM OF VIOLENT CRIME - SEX

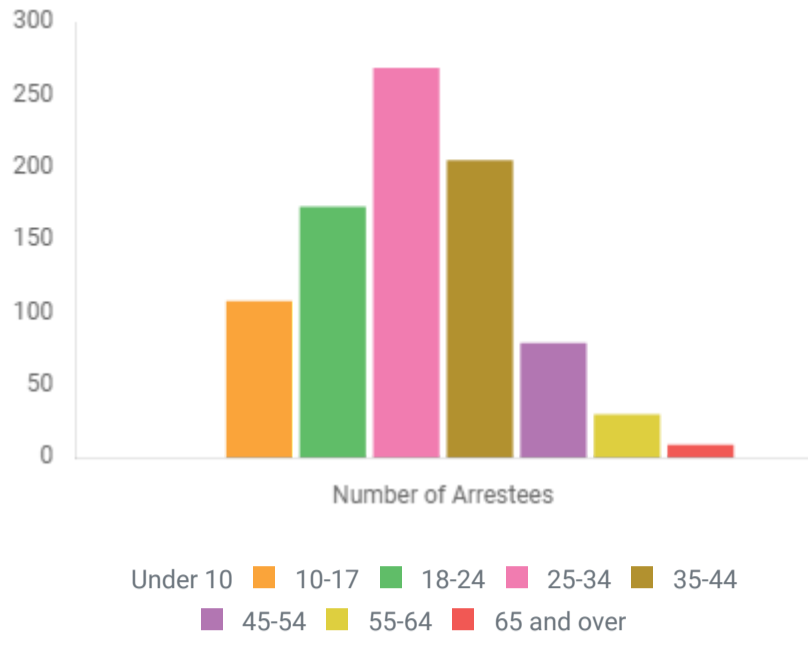

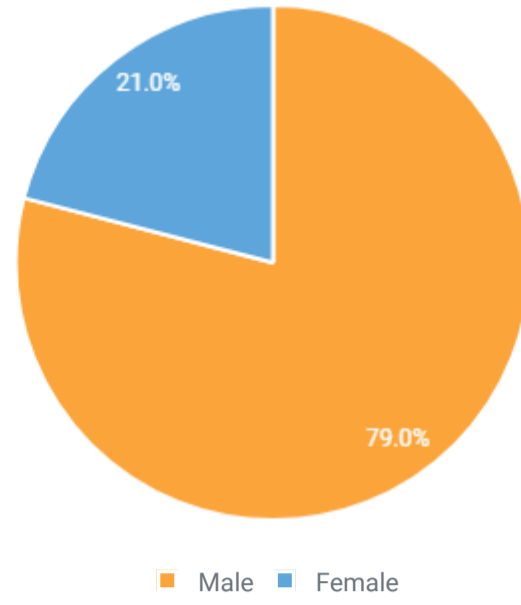

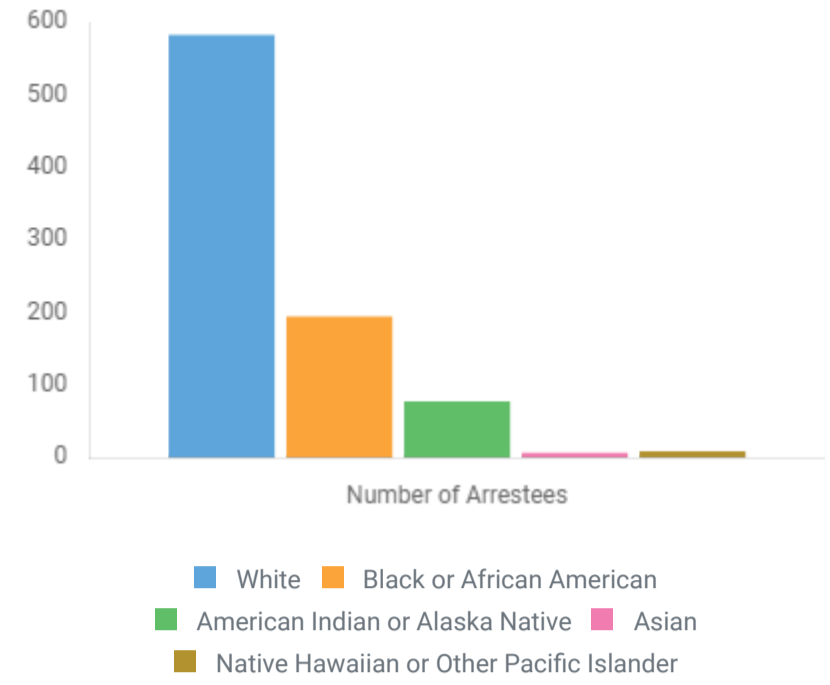
ARRESTEES OF VIOLENT CRIME - AGE

The willful (non-negligent) killing of one human being by another.

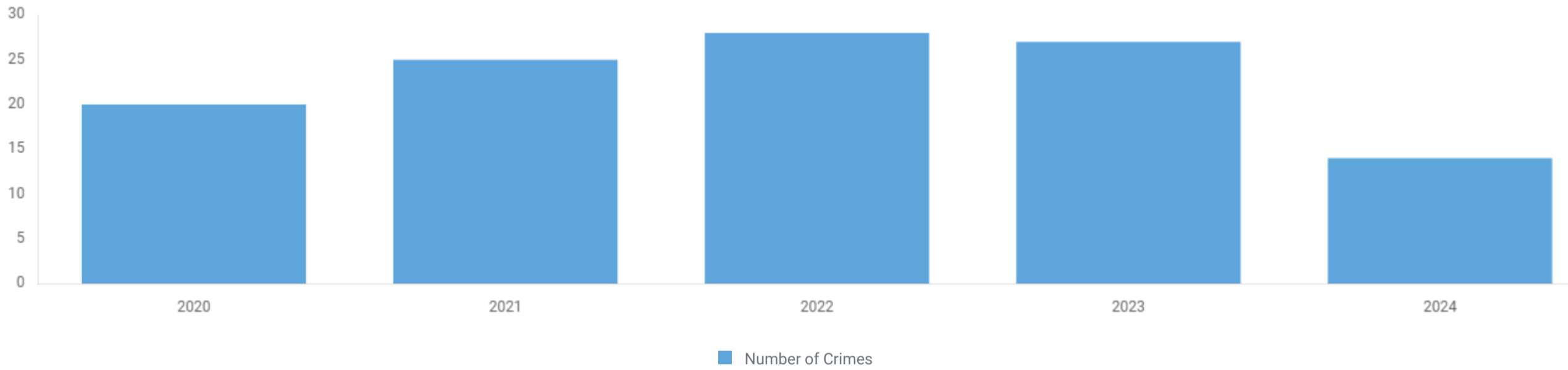

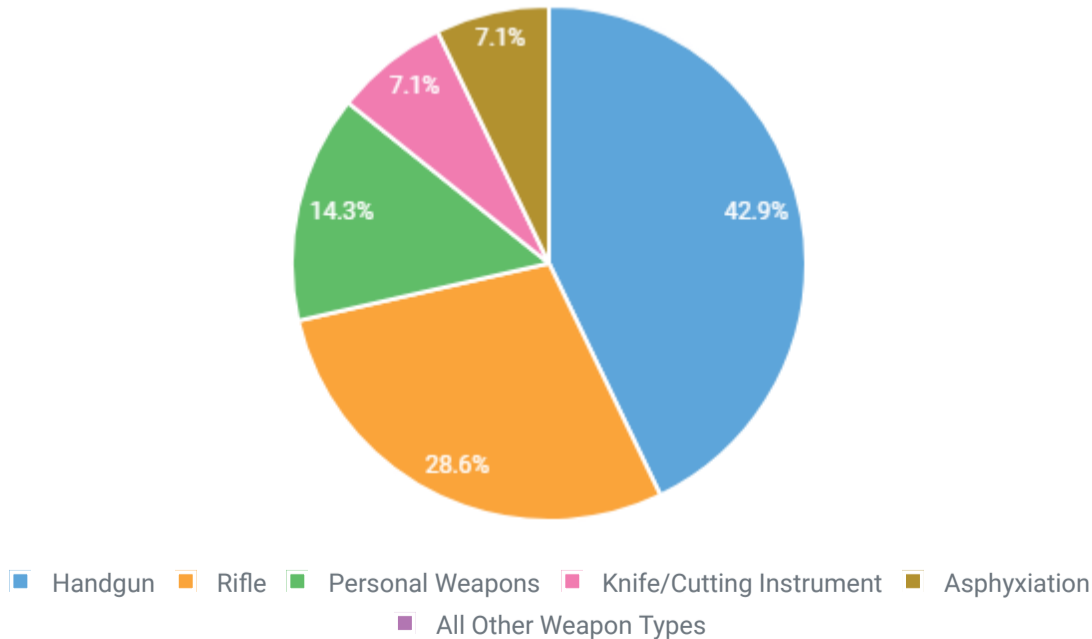

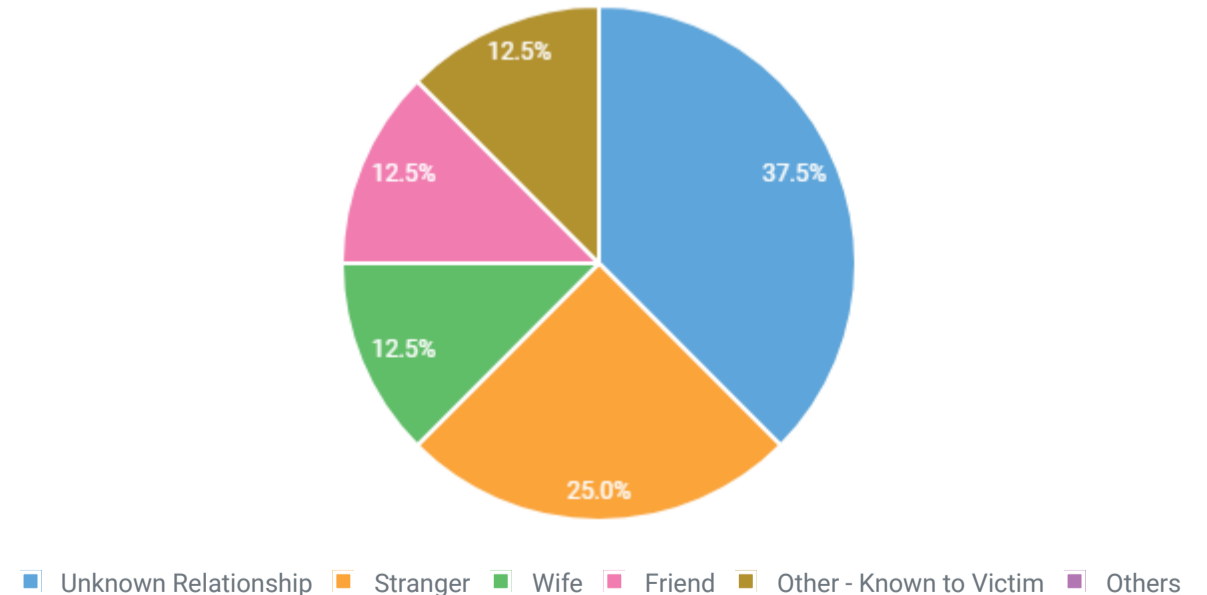

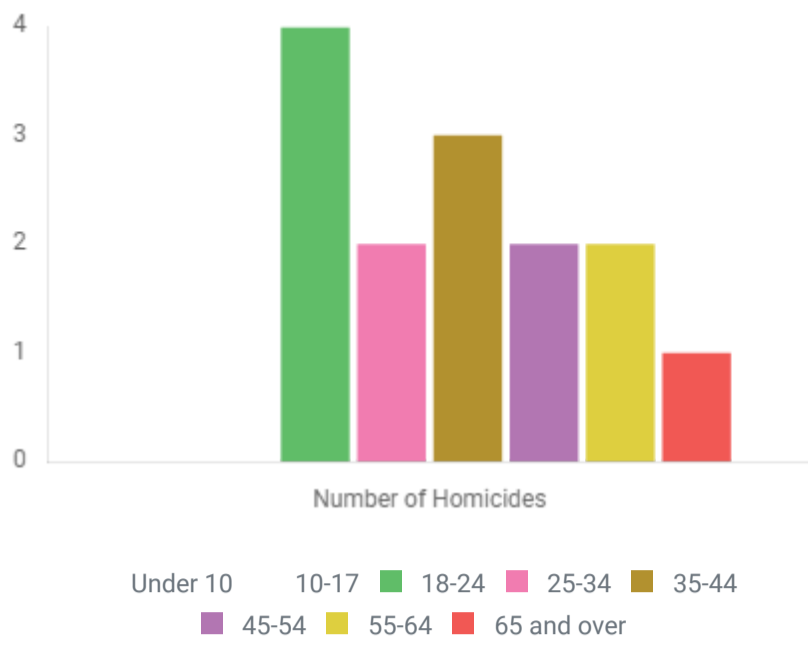
HOMICIDE - WEAPON TYPE



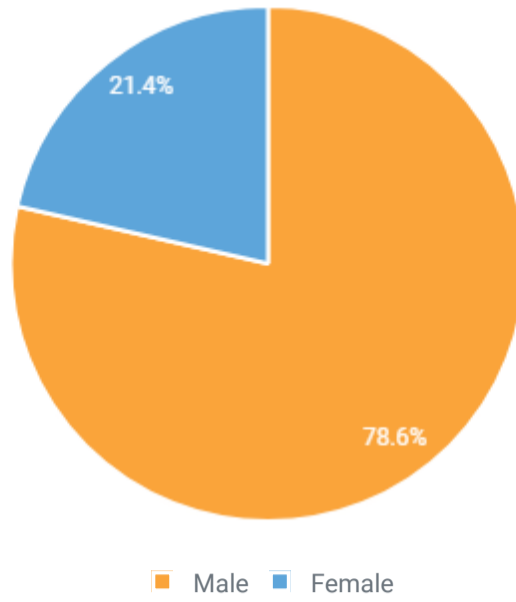
HOMICIDE BY VICTIM TO OFFENDER RELATIONSHIP



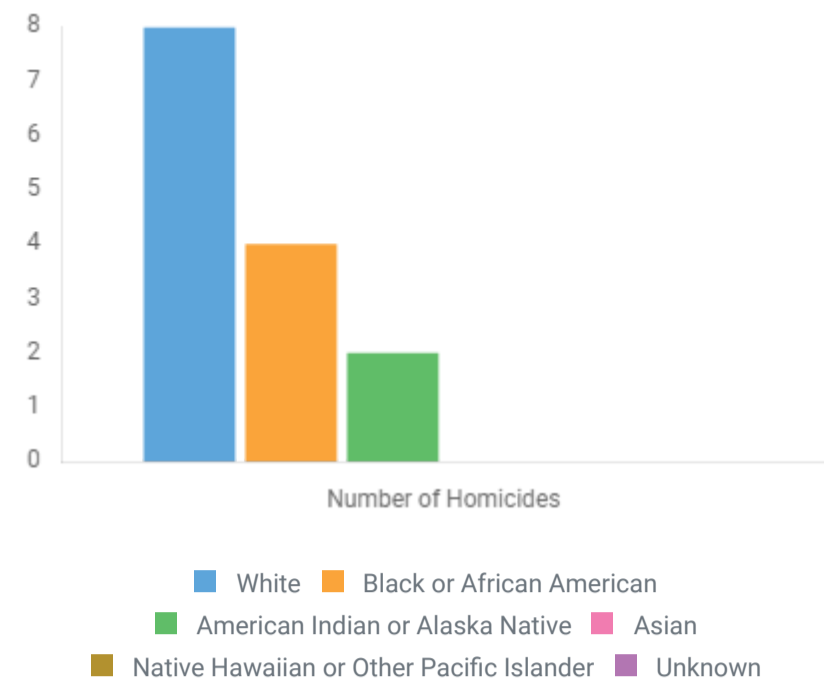
HOMICIDE BY VICTIM AGE

AGGRAVATED ASSAULT

An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in the threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness. This also includes assault with disease (as in cases where the offender is aware that he/she is infected with a deadly disease and deliberately attempts to inflict the disease by biting, spiting, etc.).

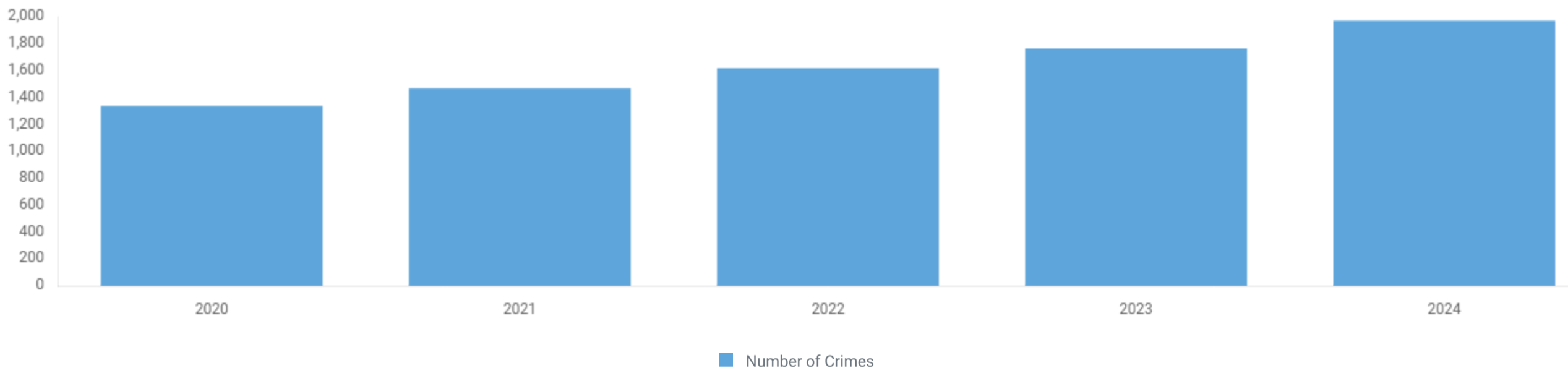

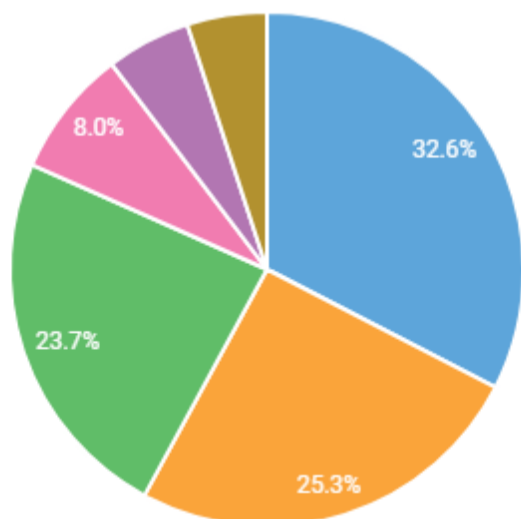

AGGRAVATED ASSAULT BY TYPE OF WEAPON/FORCE INVOLVED

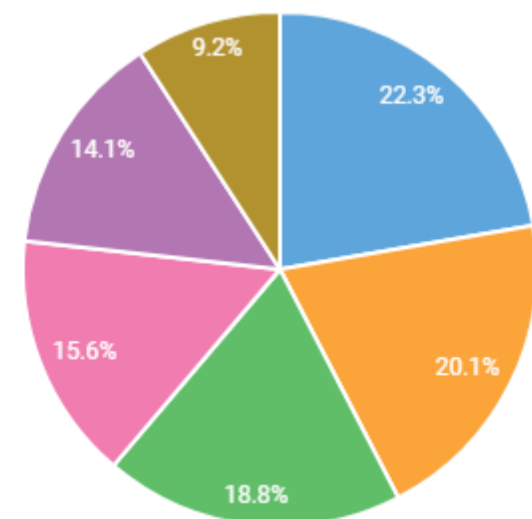

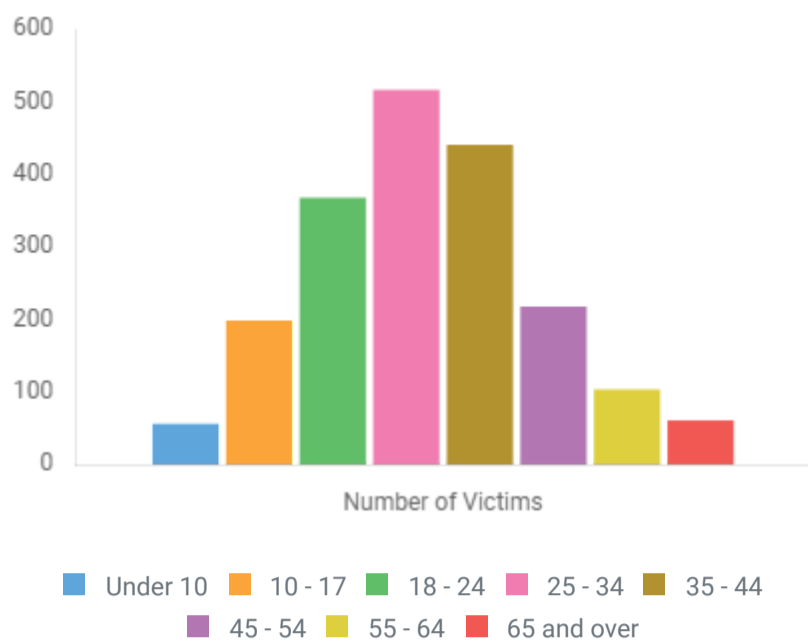

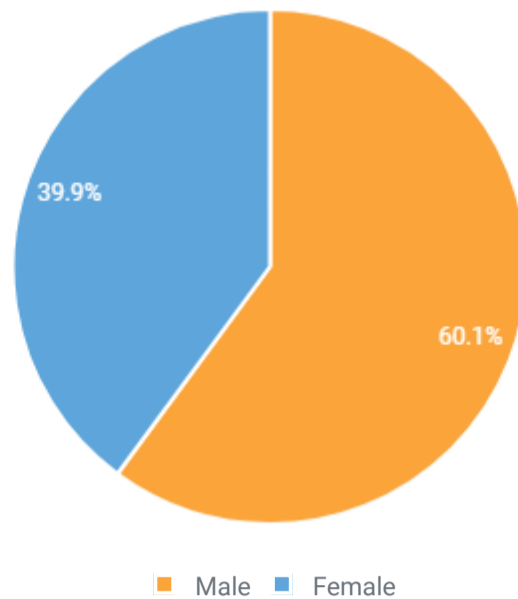

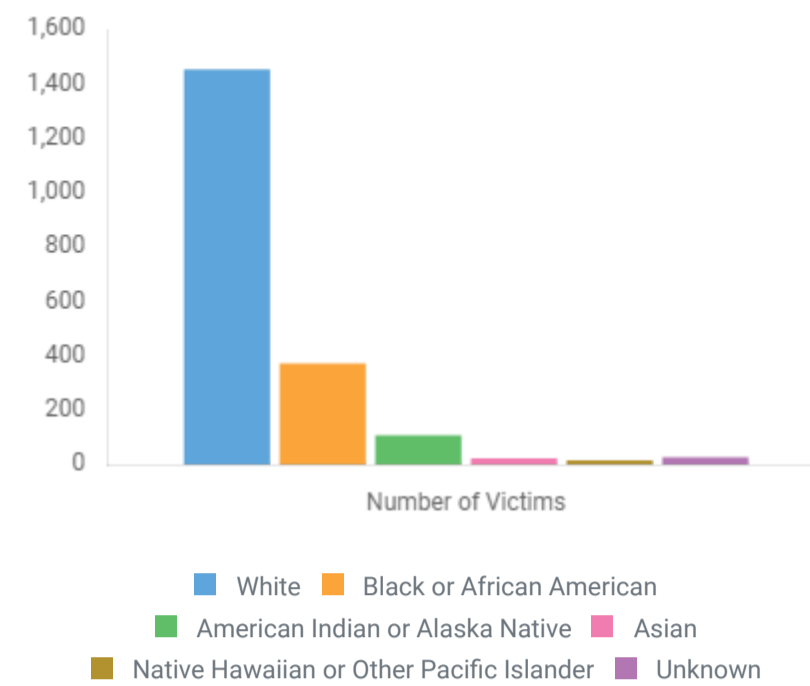
AGGRAVATED ASSAULT - VICTIM SEX

ROBBERY

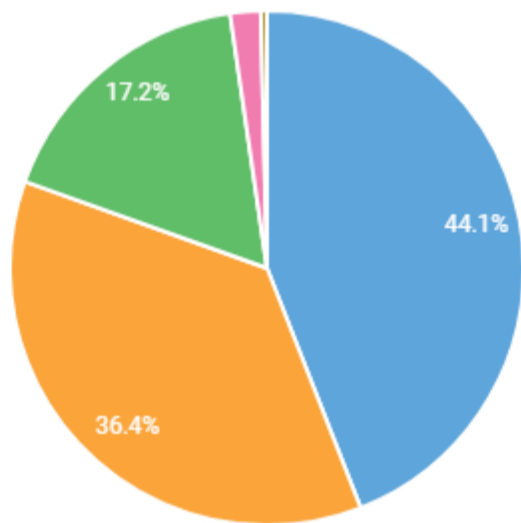

ROBBERY - LOCATION TYPE

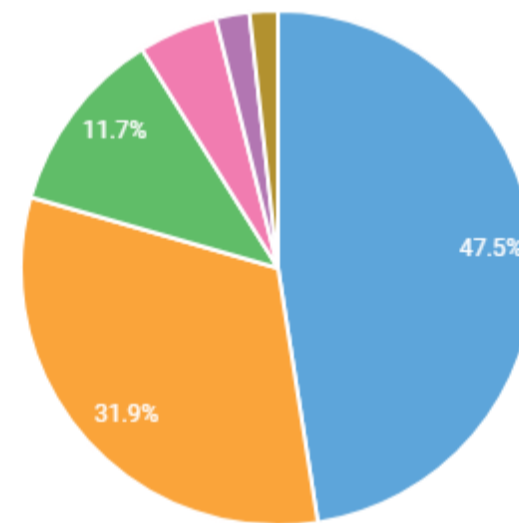

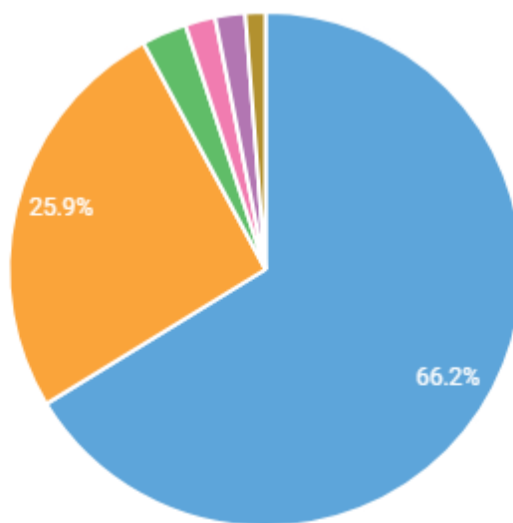

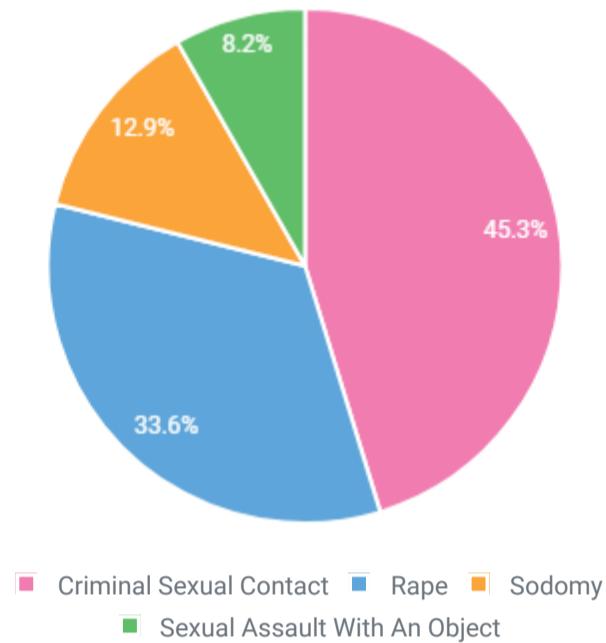

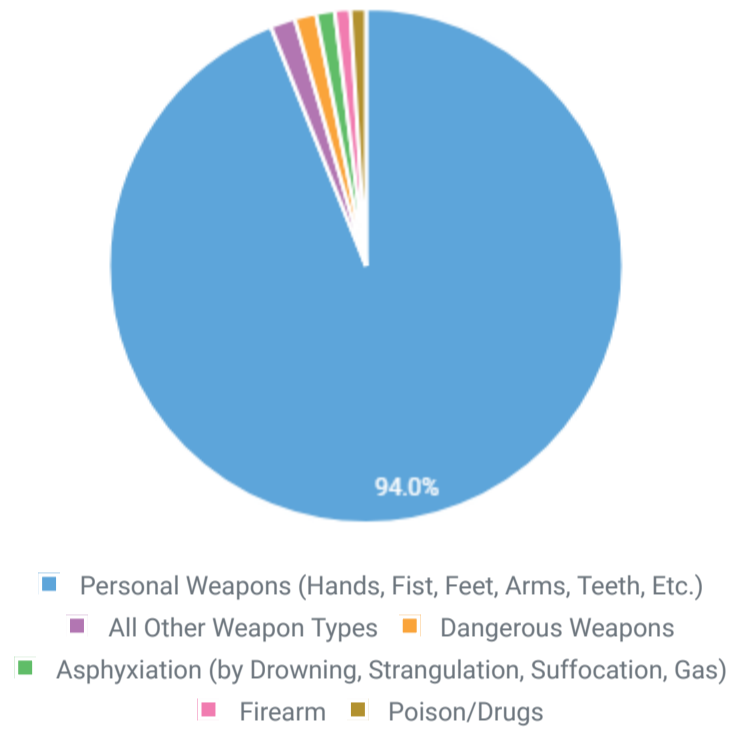

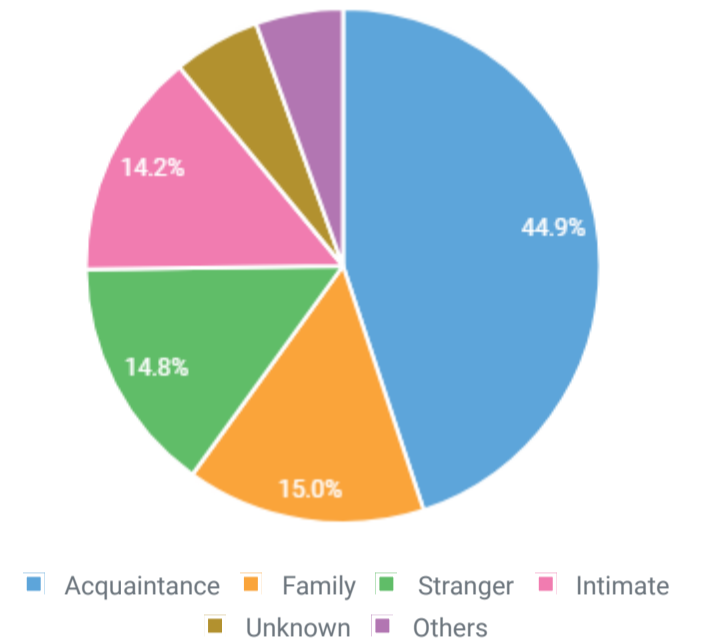
SEXUAL ASSAULT: WEAPON TYPE

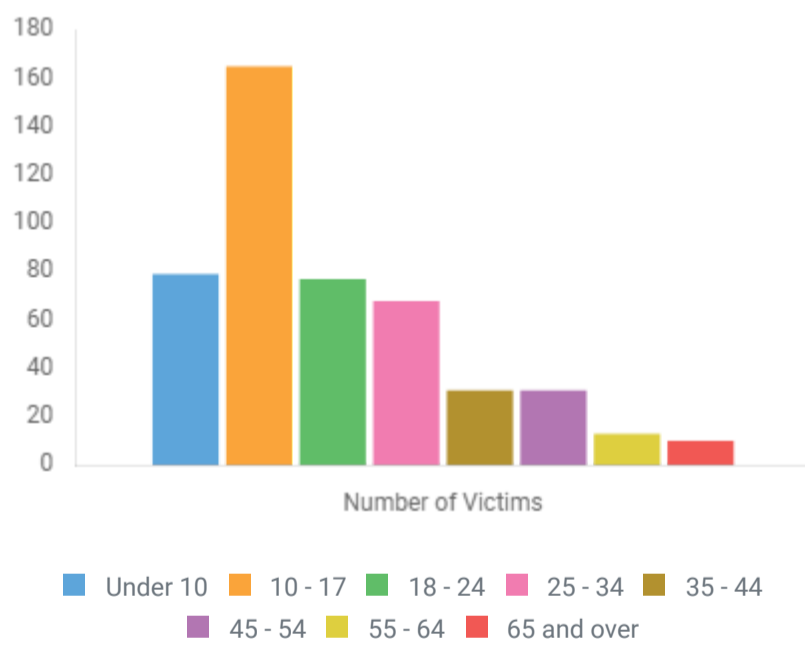
SEXUAL ASSAULT: VICTIM TO OFFENDER RELATIONSHIP

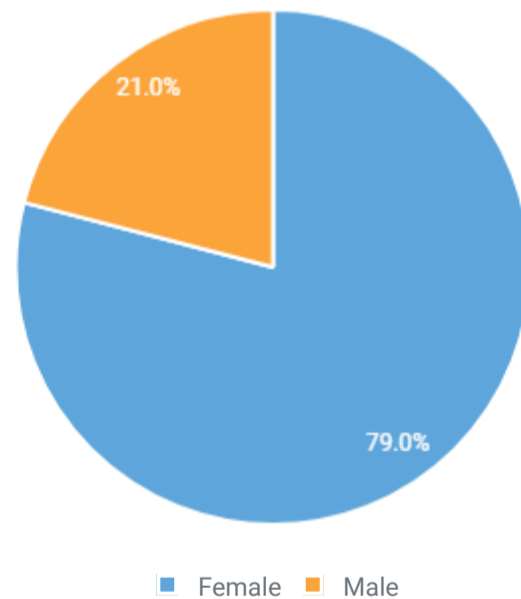
